I certify that this declaration serves as my declaration of acceptance of the nomination or election pursuant to <u>13-10-204</u> and <u>13-15-111</u> MCA.
I understand that pursuant to 13-10-211(1), MCA, a write-in candidate must file any initials, nicknames, derivatives, or diminutives of
his/her name that the candidate wishes to have counted if written in by a voter instead of how the write-in candidate's name is listed above.
Pursuant to <u>13-10-302</u> and <u>13-15-206</u> , MCA, a write-in vote may only be counted if the oval, box, or other designated voting area on
the ballot is marked and the write-in vote identifies a declared write-in candidate by any of the designations filed in the write-in
candidate's declaration of intent which must contain:
i) first and last name;
ii) initials, if any, used instead of a first name, or first and middle name, and last name;
iii) nickname, if any, used instead of a first name, and the last name; and
iv) a derivative or diminutive name, if any, used instead of a first name, and last name:
