

Voting System Chain of Custody and Seal Log – Election USB Drives

The purpose of this form is to show the control, transfer, and disposition of election USB drives. Election USB drives must be secured in containers. A security seal must be applied across a storage container of USB drives. Security seals, when removed, must be placed on the form. Document whenever security seals are removed/replaced. Each sealed container of USB drives must have an assigned chain of custody and seal log. Only SOS approved USB drives are allowed. This form is required by <u>ARM 44.3.2904 (2)(a)</u>.
