This filing fee schedule is effective for annual financial reports for years ended June 30, 2007 2015, and after. For annual financial reports for years ended October 1, 2007, and after, the annual filing fee for local government entities with annual revenues less than \$500,000 is zero.

STATEMENT OF REASONABLE NECESSITY: The change in the annual filing fee in ARM 2.4.402(7) is necessary to comply with 2-7-514, MCA, which requires the department to charge a fee based upon the costs incurred by the department in administration of the Single Audit Act. Legislatively authorized funding changes and the implementation of a new computer application, which allows for electronic reporting and increased transparency, necessitate the filing fee changes. Additionally, over the last several years, expenditures have exceeded revenues and have depleted working capital reserves. No other funding options exist as the administration of the Montana Single Audit Act is funded through local government filing fees and with general fund appropriations. Total estimated annual shortfall is \$261,000. The department is also removing extraneous information regarding revenues less than \$500,000.

It is estimated that approximately 500 entities will be affected by the change in the filing fees, which will generate an estimated \$262,100 in additional annual revenue.

If the Local Government Services Bureau receives requests for a public hearing on the proposed action from either 10 percent or 25, whichever is less, of the persons directly affected by the proposed action; from the appropriate administrative rule review committee of the Legislature; from a governmental subdivision or agency; or from an association having not less than 25 members who will be directly affected, a hearing will be held at a later date. Notice of the hearing will be published in the Montana Administrative Register. Ten percent of those directly affected has been determined to be 130 based on the number of Montana local governments.

- 3. The rules as proposed to be amended provide as follows, new matter underlined, deleted matter interlined:

4.5.308 FORAGE IDENTIFICATION AND TRANSPORTATION

- (1) Identification of forage field grown forage or harvested includes the following:
 - (a) The producer identification number.
- (b) (a) Bales sold in one ton lots or less must be identified individually using a department approved issued identification marker. A completed transportation certificate is required and must specify whether the forage was inspected for Montana or regional noxious weeds.
- (i) If each bale in lots of greater than one ton does not have a numbered tag, a transportation certificate is required.
- (ii) If each bale in a load is individually marked with a numbered tag a transportation certificate is not required.
- (c) Forage sold in bulk, including whole grain, must be accompanied by a completed transportation certificate.
- (i) (b) If colored baler twine is used for marking, only one strand of the colored twine is required per bale. However, a completed transportation certificate is required and must specify whether the forage was inspected for Montana noxious weeds or regional noxious weeds.
- (ii) Loads of bulk hay or straw not marked with colored twine may be identified with identification markers (tags) placed on the four corners of the load.
- (d) All whole grain sold in bags must be marked with a department approved identification marker.

- (e) (c) The producer shall make all reasonable efforts to ensure the whole grain certified forage is not contaminated with noxious weed seeds from the time of harvest and storage including delivery to the buyer.
- (2) Forage identification markers and transportation certificates approved by the department will be sold and distributed, respectively, by the department or its agents. The fee assessed for identification markers shall be commensurate with the actual costs of the markers.
- (3) A noxious weed seed free forage product transportation certificate issued and numbered by the department must contain the following:
- (a) a statement that this forage meets the criteria set by the Montana Noxious Weed Seed Free Forage Act;
 - (b) name and address of the producer;
 - (c) producer identification number;
 - (d) name and address of buyer;
 - (e) type of forage;
 - (f) identification marker (tags, colored baler twine, etc. and labels);
 - (g) security tie with a unique identification number;
- (g) (h) number of bales by type or tonnage or weight of grain concentrate, pellets, or other forage product;
 - (h) (i) date of sale;
 - (i) (j) seller's signature;
- (j) (k) vehicle operator or driver's signature; this must be signed upon receipt of forage-; and
- (k) (l) a statement that the forage meets Montana or regional certification standards.
- (4) All <u>baled</u> forage sold by a producer to a second party (such as a retail outlet) for resale must be accompanied by the original transportation certificate. The second party (or retail outlet) will photocopy the original transportation certificate and provide this photocopy plus a receipt to third party buyers of the <u>baled</u> forage. Third party buyers must have the photocopy of the transportation certificate and the receipt (to show where the forage was purchased) in their possession when they are transporting or storing forage in a restricted area.
- (5) Identification of forage that has been pelleted, \underline{or} cubed or other related products shall include the following:
- (a) Certified grain concentrates, pellets, cubes, or other forage byproducts must have a separate label attached showing proof of certification of the contents with the following statement: "MONTANA CERTIFIED Noxious Weed Seed Free Forage NOTE: Certification means this product has been inspected by an agent of the MT NWSFF program using recognized inspection methods and no noxious weed seed was detected."
- (b) For out-of-state pelleted, cubed, or grain concentrate products the label on the product must be in compliance with Montana's standards for Noxious Weed Seed Free Forage. Montana may enter into reciprocal agreements with other states, agencies, and/or provinces that will identify the certification procedures to be used.
- (c) All identification labels for grain concentrates, pellets, cubes, or other forage products manufactured in Montana must be obtained from the department.

- (d) Transportation of bulk loads of certified grain concentrates and pelleted and cubed materials must be secured with a security tie having a unique identifier once loaded and remain unaltered or unbroken during transit. If bulk materials are intended to be delivered to multiple destinations, a security tie is required between delivery sites. Security ties are to be used in conjunction with required markers and transportation certificates.
 - (6) remains the same.

AUTH: <u>80-7-905</u>, <u>80-7-907</u>, <u>80-7-908</u>, <u>80-7-909</u>, MCA IMP: <u>80-7-905</u>, <u>80-7-906</u>, <u>80-7-907</u>, <u>80-7-908</u>, MCA

REASON: Costs of identification markers are detailed in administrative rule, allowing users to know what the costs are. Fees are addressed in ARM 4.5.313. Security ties are being implemented for bulk certified concentrates, pellets, and cubes to prevent exposure to contamination and possible adulteration. Changes in marker requirements will aid in verifying certification and promote traceability.

ECONOMIC IMPACT: It is anticipated there will be a limited amount of bulk certified forage materials that will need a security tie. Given the low volume of security ties needed annually (up to two dozen per year), the department is not proposing a fee for security ties. There is no economic impact associated with the use of security ties. If, in the future, security ties become more widely used and a fee is needed to allow cost recovery, the department will consider implementing a fee for security ties.

There will be an economic impact for loads greater than one ton since each bale will require a marker. Cost is not expected to be significant but cannot be calculated since it will depend on the number of bales and type or marker used.

- 4.5.313 FEES (1) through (6) remain the same.
- (7) The cost for grain concentrate analysis shall be paid by the manufacturer. The product marker (label) will be provided by the department or its agent to the manufacturer of certified grain concentrates and pellets at \$0.40 per marker (label).
- (8) Only product markers provided by the department or its agents may be used. Fees for markers are as follows:
 - (a) Twine will be \$50/unit;
 - (b) Tags will be \$0.50/tag;
 - (c) Labels for grain concentrates, pellets, and cubes will be \$0.40/label;
- (d) Labels for in-state grain concentrates, pellets, and cubes made from certified noxious weed seed free materials that have already been assessed field inspection fees specified in ARM 4.5.313(1), will be:
 - (i) \$0.15/adhesive label; or
 - (ii) \$0.25/weather and tear resistant sewn-in label:
- (e) Labels for in-state bulk grain concentrates, pellets, and cubes will be \$0.20/50 pounds; and
 - (f) Ties will be provided by the department at no cost.

AUTH: <u>80-7-905</u>, 80-7-907, <u>80-7-908</u>, MCA IMP: 80-7-905, 80-7-907, 80-7-908, MCA

REASON: Listed costs for twine and tags reflect current fees that the department is formally adopting by administrative rule. A distinction is being drawn between grain concentrates, pellets, and cubes made with noncertified materials and those made with certified materials already subject to noxious weed seed free field inspection fees. A new fee is also proposed for adoption to facilitate the movement of bulk pellets and grain based on the needs of new bulk producers.

ECONOMIC IMPACT: There is no economic impact associated with formally adopting fees already established and in use. The department and the advisory council recognize the economic burden of in-state producers who pay both noxious weed seed free forage field inspections and labeling fees. We are proposing lower labeling fees for those in-state producers. There will be a positive economic impact to producers with the proposed change because adhesive label costs will be reduced to \$0.15/adhesive label, a savings of \$0.25/adhesive label and because sewn-in label costs will be reduced to \$0.25/sewn-in label, a savings of \$0.15/sewn-in label. The advisory council and department considered a need for a marker system for shipping bulk materials. This represents a new fee to facilitate movement of bulk product. The cost will equate to \$8/ton. Approximately 1,530 tons of bulk materials could be sold each year, at an estimated annual cost of \$12,240. The department and the advisory council also considered a request from a producer to have available a sewn-in label.

- (b) possess a completed department-issued designation form;
- (c) only accompany one apprentice at a time;
- (d) remain within direct voice contact with the apprentice without the use of enhancement or transmittal devices, except prescription hearing aids; and
- (e) remain within direct sight of the apprentice without the use of any magnifying or enhancing aids except prescription eyewear.

- 23.16.1712 DESIGN AND CONDUCT OF SPORTS TAB GAME (1) A sports tab game may be conducted only as a traditional sports tab game in conjunction with a single sports event with two competitors, or as a series sports tab game. A sponsor may conduct more than one sports tab game for each event.
- (a) A "traditional sports tab game" involves a single sports event with two competitors that is conducted using a sports tab card. A winner is determined by matching the numbers printed on the sports tab with the only or last digit of the score of each competitor in the sports event at the conclusion of the event. Winners may also be determined by the score at predetermined intervals during the event as long as there is also a winner and prize awarded based upon the score at the conclusion of the event. If any prize is awarded for a score attained at a predetermined interval, the value of any such prize may not exceed the value of the prize awarded for the score attained at the conclusion of the event, as provided in ARM 23.16.1714.
- (b) A "series sports tab game" is conducted using a single sports tab card in conjunction with a series of sports events. The pair of numbers on a participant's sports tab are used for each sports event in the series. The competitors in each sports event in the series may be individual teams or a combination of teams (e.g., a

group of teams designated as home teams versus a group of teams designated as away teams). Sports tabs must be sold for all events in the series of sports events and may not be sold for individual events. Winners for each sports event in the series are determined:

- (i) in the same manner as in a traditional sports tab game; or
- (ii) in the same manner as in a traditional sports tab game for the first sports event in the series. For the second and subsequent events, winners are determined by combining the scores generated by each competitor in the previous events.
- (2) A winner or winners of a sports tab game are determined by matching the appropriate numbers on a participant's sports tab with the only or last digit of the competitors' score at the end of the sports event, and if designated before the event by the sponsor, at intervals during the sports event, as provided in ARM 23.16.1714.
- (3) Before the sale of any sports tabs in a sports tab game, the sponsor shall describe the game by prominently displaying the following information on the sports tab card or on a board to which the card is attached:
 - (a) name of the competitors in the sports event;
 - (b) date of the sports event or dates of the series of sports events;
- (c) notification of which competitor's score corresponds to the first and second numbers on the sports tab;
 - (d) name of the sponsor;
 - (e) cost of a sports tab;
 - (f) total dollar value of all prizes to be awarded to winners;
 - (g) total amount to be retained by the sponsor;
- (h) dollar amount or type and value of merchandise to be awarded to each winner;
- (i) predetermined intervals, as provided in ARM 23.16.1714, during the sports event for which prizes are to be awarded, if any; and
- (j) name of the competitors and the date of the sports event that will be substituted for the original sports event if it is cancelled.
 - (4)(3) After sale of the sports tabs begins, the sponsor:
 - (a) may not cancel the sports tab game or alter the game in any manner; and
- (b) shall award all prizes <u>only</u> at the <u>end conclusion</u> of the <u>single</u> sports event <u>in a traditional sports tab game</u>, or at the <u>conclusion of all sports events in a series sports tab game</u>, in accordance with the description required under (3)(2), regardless of whether all sports tabs on the sports tab card are sold to participants before the start of the sports event.
- (5)(4) The sports tab games purchased must have a permanent, unduplicated serial number printed on the sports tab card and have the same number printed on each sports tab affixed to the sports tab card. The sports tab cards must not have any concealed numbers on the card other than those concealed by the 100 sports tabs.
- (6)(5) All money paid to participate in each sports tab game shall be kept separate from any other money. No share for charitable contributions or administrative expenses may be separated from the total amount collected until after the sports event has occurred.

23.16.1714 SPORTS TAB GAME PRIZES (1) For the purposes of this rule, "cost of the sports tabs" means an amount that is equal to the amount paid by a participant for a single sports tab multiplied by 100.

- (2) Winners may be determined by the score at predetermined intervals during the event as long as there is also a winner and prize awarded based upon the score attained at the end conclusion of the event. If any prize is to be awarded for a score attained at a predetermined interval during a sports event, the value of any such prize may not exceed the value of the prize to be awarded for the score at the end conclusion of the event.
- (3) Except as provided in (6)(5), a sponsor shall pay to the winners of a sports tab game at least 90% of the cost of the sports tabs. The sponsor may retain up to 10% of the cost of the sports tabs.
- (4) The total value of all prizes awarded in a sports tab game may not exceed \$2,500. Prizes must may be in cash or merchandise, or a combination of cash and merchandise.
- (5) If merchandise is awarded, the purchase price paid for the merchandise is considered to be the value of the prize. Except as provided in (6)(5), if the value of the merchandise is less than 90% of the cost of the sports tabs the difference must be awarded to the winners in cash.
- (6)(5) A sponsor who is a nonprofit organization may retain up to 50% of the cost of the sports tabs if the organization meets the requirements of 23-5-503, MCA.
- (7)(6) All prizes must be available for distribution to winners immediately at the end conclusion of the sports event, or at the conclusion of all sports events in a series sports tab game.

- 23.16.1715 SPONSOR RECORD KEEPING REQUIREMENTS (1) After a winning sports tab is submitted to the sponsor and a prize is awarded, the sponsor shall cancel the tab, by whatever means chosen, and attach the cancelled tab to the sports tab card or board. A sports tab that was not sold to a participant must remain attached to the sports tab card.
- (2) A sports tab that was not sold to a participant may be revealed by the sponsor after the beginning of the sports event, but all unsold sports tabs must remain attached to the sports tab card.
- (2)(3) The sponsor shall retain a sports tab card that was used in a sports tab game for at least one year after the date of the sports event upon which the sports tab game was based.
- (3)(4) If merchandise is awarded as a prize, the sponsor shall retain proof of the purchase price of the merchandise for one year after the date of the sports event.

RATIONALE AND JUSTIFICATION: Prior to the 2015 Legislature's passage of HB 38, sports tab games were only authorized to be used in conjunction with a single sports event. The legislative amendment to 23-5-501, MCA, authorized the use of sports tab games to be used in a series of sports events, in addition to single sports events as previously authorized. These amendments are reasonably necessary to implement HB 38, to differentiate between a traditional sports tab game and a series sports tab game, and to clarify the scope of the rules that apply to traditional sports tab games and series sports tab games. Because sports tab boards contain 100 tabs (or chances), these rule amendments largely adopt the administrative rules for the operation of traditional and series sports pools conducted on a 100-square (100 chances) sports pool board.

Unlike a sports pool where the identification of the participants is written on a sports pool board, only the sports tab game participants know the numbers which are printed on their selected tabs. As a result, the rules require participants in a series sports tab game to retain their sports tabs until the conclusion of the sports event in a traditional sports tab game, or until the conclusion of all events in a series of events. At that time, the winning tab numbers are redeemed by submitting them to the sports tab game sponsor for prize payout. The sponsor then attaches those winning tabs to the sports tab game card, as currently required by these rules.

As in a sports pool game, prizes in a sports tab game are based upon the price per tab. Therefore, when a sports tab game sponsor does not sell all of the sports tabs to participants, the unsold tabs belong to the game sponsor and must remain attached to the sports tab card for record keeping and reconciliation purposes. These amendments, however, allow the sponsor to reveal the concealed numbers printed on the unsold tabs in order that the sponsor may determine whether any of the unsold tabs contain winning numbers.

The amendments make other nonsubstantive stylistic changes for internal consistency, clarity, and ease of reading.

Manual (the Manual), which was adopted and incorporated by reference into ARM 37.87.2203, effective November 15, 2013, under MAR No. 37-649. The department also proposes to repeal ARM 37.87.2202, 37.87.2205, 37.87.2225 and 37.87.2233, due to the proposed Manual changes, which will eliminate the need for specific Respite Care Service rules.

ARM 37.87.2203

The proposed Manual revisions, effective September 1, 2015, are described as follows:

- (a) The Manual has had general comprehensive revisions of typesetting, layout, formatting, and nonsubstantive grammar changes, which are intended to improve navigation and reading of the Manual;
- (b) Non-Medicaid Respite Care Services for youth with serious emotional disturbance, which are currently provided in ARM 37.87.2202, 37.87.2205, 37.87.2225, and 37.87.2233 have been incorporated into the Manual;
- (c) Room and Board Account and Systems of Care Account sections have been amended with additional specification as to how and when those accounts' funds may be used for youth in state or tribal custody;
- (d) Additional language has been added to the Supplemental Services Program, Room and Board Account, and System of Care Account sections to specify income eligibility determinations for these services, including family income guidelines, joint income calculations, Social Security income, and Social Security Disability Income; and
- (e) Additional language has been incorporated to define further the permissible use for Non-Medicaid funding sources.

These revisions to the Manual are necessary because all other Non-Medicaid Services Program services, which are described in (1) of this rule, were previously adopted into the Manual. By adding Non-Medicaid Respite Care Services to the Manual, the department completes its consolidation, into a single source, of its authority, procedures, and references for all Children's Mental Health Bureau's Non-Medicaid Services Programs.

The department proposes to amend this rule further by amending the effective date of the revised Manual in (3) and the language adopting the Manual by reference, to be consistent with ARM 1.2.210, regarding how agencies reference adopted and incorporated legal sources, other laws, or documents into administrative rule.

Finally, the department proposes amending (4) for the effective date and abbreviated reference of the revised Manual and the department's web site address where an electronic copy of the Manual can be located.

An electronic copy of the proposed revised Manual can be accessed through the department's revised internet link described in (4), or a paper copy of the proposed revised Manual may be requested from CMHB at the mailing address also described in (4).

ARM 37.87.2202, 37.87.2205, 37.87.2225, and 37.87.2233

As a result of the above-described proposed actions, the department considers it necessary to propose the repeal of ARM 37.87.2202, 37.87.2205, 37.87.2225 and 37.87.2233, as the regulations and procedures for Non-Medicaid Respite Care Services for youth with serious emotional disturbance will be located within the Manual, which removes the need for specific Respite Care Service rules.

The department makes the proposed Manual revisions, rule amendments, and rule repeals only after having given careful consideration to (a) its current internal policies and the Manual in relationship to the affected administrative rules; (b) feedback received from providers and program participants regarding the need for greater clarity in the Manual; and (c) the department's required periodic review of its administrative rules and policy manuals. The department did explore alternatives to the above-described actions, but as the intended actions clarify and improve operational procedures in the operation of its Non-Medicaid Services Program, the department contends the proposed Manual and rule amendments and rule repeals are the most efficient means of meeting its program goals.

FISCAL IMPACT

There is no anticipated fiscal impact resulting from the proposed rulemaking and Manual revisions.

BOARD APPOINTEES AND VACANCIES
