<u>REASON</u>: In response to recommendations from the department's legal staff, the board is proposing to amend its rules on acupuncturist continuing education to align with 37-1-306, MCA, and standardized department procedures. This alignment will standardize renewal, administrative suspension, and audit procedures across all boards, therefore increasing organizational efficiency. The department determination of audit percentages will conserve board resources and emphasize a data-driven approach to audit administration. Further amendments also clarify that licensees not in compliance with continuing education requirements may be subject to administrative suspension in alignment with 37-1-321, MCA.

Implementation citations are being amended to accurately reflect all statutes implemented through the rule.

REASONABLE NECESSITY: The department, through its Trust Lands Management Division, has a statutory and constitutional duty to generate revenue for the trust beneficiaries, primarily common schools. In 2019, the Montana State Legislature, through Senate Bill (SB) 41, modified 77-3-411, MCA, to allow oil and gas lease auctions on state land to be conducted in alternate formats aside from inperson oral auctions. 4. STATEMENT OF REASONABLE NECESSITY

The Department of Public Health and Human Services (department) proposes to amend ARM 37.40.830 to update its Medicaid hospice reimbursement fee schedule referenced in (12), effective October 1, 2020. This new fee schedule is being proposed in accordance with changes in federal hospice reimbursement rates set by the Centers for Medicare and Medicaid Services (CMS) under the final Medicare hospice rule published on August 4, 2020 (CMS-1733-F).

The proposed fee schedule implements an approximate, aggregate reimbursement rate increase of 2.4%, as computed and published by CMS, which will apply to providers in all 56 counties. Montana hospice rates are affected by a wage index applied geographically by county. The 2021 wage index has increased for Carbon and Yellowstone Counties by approximately 0.68%. Effective October 1, 2020, Golden Valley County is now calculated using a rural index of 0.8569% which is a decrease from the Fiscal Year 2020 urban index rate of 0.9224%. The wage index for Cascade County has decreased by 1.56%. The wage index for Missoula County has increased by approximately 0.45%. The remainder of the Montana counties are subject to the rural index rate, which decreased by approximately 1.41%. Additionally, one hospice provider will see a hospice reimbursement rate decrease of 2% for failure to comply with the federal quality data submission requirements during the prior fiscal year. A copy of the proposed hospice fee schedule can be found at https://medicaidprovider.mt.gov/proposedfs.

The proposed rule amendment is necessary to pay Medicaid providers according to the current Medicare fee schedule effective October 1, 2020. Failure to amend the rule will result in a deficient state hospice reimbursement rate from the current federal rate, which would result in underpayment to hospice providers, and introduce an inability for the state to comply with federal requirements pertaining to hospice providers.

Fiscal Impact

The proposed amendment to ARM 37.40.830 will have a fiscal impact on the hospice program. Funds impacted will be from the federal Medicaid fund source (03583) and general fund source (01100). In Fiscal Year (FY) 2020, approximately 436 Medicaid recipients received the hospice benefit. A majority of the Medicaid hospice program's approximately \$4.1 million budget provides reimbursement for hospice services provided in nursing facilities in the form of room and board for inpatient nursing facility hospice. The proposed rate increase of 2.4% is estimated to have a fiscal impact of \$114,705 in combined state and federal funds as compared to FY 2020.

The department intends for the increase in hospice rates to be retroactive to October 1, 2020. Any decreases in hospice rates will not be applied retroactively and would be effective upon adoption of the proposed rule amendment.

- 2. On February 11, 2021, a public hearing was held on the proposed amendment of the above-stated rules in Helena via the remote conferencing platform. Several comments were received by the February 12, 2021 deadline.
- 3. The department has thoroughly considered the comments received. A summary of the comments and the department's responses are as follows:

<u>COMMENT 1</u>: Several commenters opposed the increase in license renewal fees in ARM 24.135.402 and questioned what licensees get in return for higher license fees.

<u>RESPONSE 1</u>: As explained in the proposal notice, it is necessary to increase the renewal fees to maintain fees commensurate with the costs of administering the program. Unless the fees increase as proposed, the program's operating funds shortfall will continue to grow, and the program will lack sufficient revenue to cover regular FY21 expenses.

Application and renewal fees are the only way the program gets funding and current fees are too low as the program is operating with a negative cash balance. Licensure fees cover costs for program employees' salaries and benefits, travel costs, vehicle expenses, computer and office equipment including cell phone usage, and occasional IT and legal expenses, as may arise.

<u>COMMENT 2</u>: Several commenters supported a smaller renewal fee increase than what is proposed in ARM 24.135.402.

RESPONSE 2: See RESPONSE 1.

<u>COMMENT 3</u>: One commenter reported concerns over the amount of visits program staff performs on their business location and proposed the department increase the fine for operating without a license instead of increasing license renewal fees.

<u>RESPONSE 3</u>: The department checks approximately 50 to 60 sites annually for crane operator licensure, including construction sites, oil refineries, mines, power companies, etc. The inspector uses information on building permits to plan inspections, as well as visually scouting for cranes when driving to building sites or businesses. While trying to cover as many sites as possible in an area, the inspector may visit the same locations depending on cranes in use or other information available.

The department's authority to seek remedy in court for the unlicensed practice of crane or hoist operation, or to issue citations and fines for licensed operators found working without proof of licensure is found in statute at 50-76-109 and 50-76-114, MCA, respectively. Any change to this authority, including the statutory \$100 fine in 50-76-114, MCA, must be accomplished through the legislature.

<u>COMMENT 4</u>: Two commenters suggested abolishing the program and utilizing the national certifications available.

<u>RESPONSE 4</u>: The department, through the program, is required to license and regulate crane and hoist engineers by statute at Title 50, chapter 76, part 1, MCA. Changes to the established statutory duties or elimination of the regulation can only be accomplished through the legislature.

<u>COMMENT 5</u>: Several commenters requested the program come into compliance with OSHA (Occupational Safety and Health Act). The commenters stated that currently the qualifications for a Montana crane operator license are not checked to the national industry standard.

<u>RESPONSE 5</u>: No amendments related to aligning with OSHA or other federal regulations were proposed; therefore, this action cannot be accomplished in a final notice. The department may consider the suggestions in future rulemaking.

<u>COMMENT 6</u>: A commenter asked if the state would be liable if someone was killed by the operation of an unlicensed operator if the state allowed the operator to continue working.

RESPONSE 6: This comment is outside the scope of this rulemaking project.

<u>COMMENT 7</u>: Some commenters expressed concern about the rules hearing being held via an electronic platform. The commenters asserted that many attendees could not give public testimony due to being muted.

<u>RESPONSE 7</u>: The department has conducted over 100 board meetings and rule hearings electronically over the past year. The platform used in the rules hearing allowed attendees to unmute themselves and provide comment and did not

intentionally block anyone from providing comment. The hearing officer received several public comments on the platform without issue. Additionally, the notice clearly provided several other formats to provide public comment in addition to the public hearing, such as e-mail, regular mail, and facsimile. The department considers and responds to all timely comments and no method of providing comment is any better or more well-received than another.
