3. <u>REASONABLE NECESSITY STATEMENT</u>: The term "deep" was added to the board's fee rule in 2006 as meaning the same as a "sound and electrical" modality. In 2015, the board struck "deep" from the fee rule to align with terminology used in board statutes and also by rule established a "deep modality endorsement" and definitions for "deep modalities" and "deep modality endorsement."

In 2019, Senate Bill 59 eliminated the requirement for occupational therapists to obtain an endorsement to utilize sound and electrical physical agent modalities in practice. Later that year, the board amended the rules to implement the 2019 statutory changes. While reviewing and comparing the board's statutes and rules to existing application processes, staff noticed that only "superficial" (37-24-105, MCA) and "topical medications" (37-24-107, MCA) endorsements are now provided for in

statute. "Deep modality" endorsement does not appear in Title 37, chapter 24, MCA, and is not statutorily authorized.

The board determined it is reasonably necessary to strike the definitions of "deep modalities" and "deep modality endorsement" in ARM 24.165.302 and repeal ARM 24.165.505 to remove obsolete and inaccurate rule language. These amendments will align the board's rules with the statutes to reflect superficial and topical medications endorsements as the only two modality endorsements the board has authority to issue. These changes will not alter or impact the scope of practice for Montana licensed occupational therapists.

<u>24.165.302</u> DEFINITIONS For the purpose of this chapter the following definitions apply:

(1) remains the same.

(2) "Deep modalities" means the use of a sound or electrical physical agent modality which penetrates past the subcutaneous layer of fat into the muscle through the application of heat, cold, ultrasound, phonophoresis, or iontophoresis.

(3) "Deep modality endorsement" means that a licensed occupational therapist has met the statutory requirements in the use of sound and electrical physical agent modalities and occupational therapy techniques involving topical medications.

(4) through (11) remain the same but are renumbered (2) through (9).

(16) Delete Subsection 903.2.8 and replace with the following:

"1. An approved automatic sprinkler system installed in accordance with Section 903.3 shall be provided in all Group R buildings meeting any of the following criteria: "a. 9 or more transient guests or 5 or more transient guestrooms in R-1 or R-2 occupancies;

"b. 9 or more occupants in other than dwelling units;

"c. 5 or more dwelling units; or

"d. more than 2 stories in other than dwelling units.

"2. In lieu of the above required automatic sprinkler system in buildings not more than three stories above the lowest level of exit discharge, each transient guestroom may be provided with at least one door leading directly to an exterior exit access that leads directly to approved exits.

"3. "Transient guest" for the purpose of this subsection shall mean an occupant who is primarily transient in nature, staying at one location for 30 days or less."

"4. "The requirements for automatic sprinkler systems for R-4 occupancies are found in ARM 24.301.146."

<u>REASON</u>: The 67th Montana Legislature passed Senate Bill 178, an act prohibiting state building codes from requiring mandatory installation of fire sprinkler systems in certain residential buildings. The bill was signed by the Governor and became effective April 22, 2021, and is codified at 50-60-203, MCA.

The bill prohibits state building codes from requiring fire sprinkler systems in single-family dwellings or residential buildings containing no more than two dwelling units. The department determined it is reasonably necessary to amend this rule to implement Senate Bill 178 by clarifying the buildings that must have automatic sprinkler systems under the new law.

REASON: The department is proposing to amend the above-stated rule with nine new tests and associated fees resulting in improved quality of work for clients, decreased turnaround time for test results, clients being offered more diagnostically reliable and cost-effective testing options, the potential for more federal funding, lowered overhead costs, and greater operational flexibility and efficiency.

Bovine Viral Diarrhea Virus BVDV SNAP Test

The BVDV snap test would take the place of any single animal submissions that we currently perform ELISA, PCR, or virus isolation on (>2000 tests in FY20). In these single animal cases, the snap test will drastically reduce our turnaround time and lab time investment from several hours or days to less than an hour. The following table illustrates the projected time to complete testing within the lab section, projected turnaround time from sample receipt to issuing results, and the associated test fee.

In addition to time savings for MVDL staff and decreased turnaround time for clients/producers in Montana, the proposed BVDV SNAP test fee of \$7/test will provide a significant savings over our current BVDV PCR test (\$40/test) and BVDV virus isolation assay (\$34/test).

The main benefit of the BVDV SNAP test would be when we receive a single test submission or a low number (1-5) of test submissions. The SNAP test will result in a significantly faster turnaround time for a limited number of samples and will reduce the time burden on our lab technicians for these cases. Once the samples numbers get higher (such as the testing of a large herd) it may be more efficient to do the ELISA or PCR using the pooling option. The availability of the SNAP test option will allow our staff to mix and match testing methodologies to provide greater operational flexibility and efficiency.

Equine Virus Arteritis (EVA) Virus Neutralization Test

EVA is a National Animal Health Laboratory Network (NAHLN) scope disease, and thus, we are proposing to add this test as it is in the best interest of the MVDL to become qualified to perform all diagnostic tests that increase our standing with NAHLN. The number of NAHLN scope diagnostic tests a lab is qualified to perform is an input into a capability matrix which determines the amount of annual federal funding a NAHLN lab receives.

The EVA test utilizes most of the same reagents we currently have on hand and use for other serum neutralization (SN) tests, minus the cell line and virus. The upfront investment for the additional components is \$287. Once set up and qualified, we will have exceedingly low supply overhead costs since the virus and cell line can be propagated and stored indefinitely going forward.

Giardia SNAP Test

The MVDL is proposing to switch our giardia test method to the IDEXX SNAP test, which is a USDA-approved diagnostic assay. The current giardia ELISA is twice as expensive (\$34/test) as the giardia SNAP test (\$18/test), and the bench time required for the ELISA (60 minutes) is double that of the SNAP test (30 minutes). By offering this test, we will provide our clients with a diagnostically reliable and more cost-effective testing option.

Mycoplasma Bovis PCR Test

Currently, the MVDL has no diagnostic test capable of determining mycoplasma speciation. Since most of our clients know that we cannot speciate mycoplasma bovis, we suspect a lot of them either have us culture for mycoplasma in general, or they send samples directly to other labs for speciation. For mycoplasma testing specifically, often this test is incorporated as part of a respiratory PCR panel at other laboratories, something that we refer out of state with regularity. Offering this test would significantly improve the quality of our diagnostic workups for respiratory disease.

Also, offering a PCR test would result in a turnaround time for our clients of 2-3 days rather than the >7 days for a mycoplasma culture. Once the assay is online and qualified, the MVDL could consider incorporating it into a respiratory panel, a diagnostic test offering that will primarily benefit cattle producers during the fall and winter.

Coxiella/Chlamydophila PCR

The MVDL has received occasional interest from our clients regarding this testing, specifically in sheep. These two kits use the same reagents and platforms for extraction and the expendables and turnaround time would be the same as any of our other routine PCR tests. The time and investment we would need to bring these tests online is anticipated to be the cost of verifying the tests, something we do on a regular basis for new tests, new kits, changes in reagents/suppliers, or any other material change to a diagnostic assay. Offering these assays would significantly improve the quality of our workups for livestock abortions during the winter/spring reproductive season and lay the groundwork for future incorporation of these assays into a PCR abortion panel.

Pregnancy Test

The rapid visual pregnancy test is a USDA-licensed ELISA test used for the detection of pregnancy-associated glycoproteins from 28 days post-breeding in goats and cattle, from 35 days post-breeding in sheep, and from 40 days post-breeding in water buffalo and bison. Early detection of pregnancy in ruminants is important for improving reproductive efficiency in commercial herds. No other serum/plasma test for detection of pregnancy in livestock is currently offered by MVDL and would serve as a non-invasive and useful diagnostic testing modality for livestock producers. MVDL proposes adding this test at a cost of \$4.50 per test. This cost is consistent with fees charged by other state labs performing this test offering.

RHDV PCR

Rabbit Hemorrhagic Disease Virus (RHDV), considered a foreign animal disease, has recently been identified in Yellowstone County, Montana. This virus is lethal in many different lagomorph species (both wild and domestic) and may infect other wildlife species as well. Quick laboratory diagnosis is paramount to preventing the spread of the virus. The USDA has developed a rapid real-time PCR assay that can identify the presence of RHDV in clinical samples, and MVDL has been activated as a surveillance laboratory for RHDV by the Department of Livestock and the USDA.

Making this PCR test accessible to stakeholders is directly in line with the mission of the Department of Livestock "to control and eradicate animal diseases." MVDL proposes adding this test at a cost of \$40.00 per test, reflecting the same price as other NALHN-scope PCR tests we offer.

Clostridium perfringens Typing PCR

Clostridium perfringens is a bacterial pathogen capable of causing diarrhea and death in cattle, especially neonates, resulting in significant economic hardship to livestock producers. Certain Clostridium sp. are normal inhabitants of the GI tract of animals, while other types produce potentially lethal toxins. To guide treatment, determination of the type of Clostridium perfringens present and the toxins produced by the bacteria in a clinical sample is necessary. Currently, MVDL does not have the capacity to perform C. perfringens toxin typing; thus, all requests are referred to other veterinary diagnostic laboratories. Adding this test would be extremely useful to cattle producers and veterinarians in Montana, potentially improving patient outcomes by decreasing turnaround time for dissemination of testing results and guiding treatment strategies.

MVDL proposes adding a Clostridium perfringens typing PCR at the cost of \$40.00 per test which is consistent with the cost of other MVDL PCR tests.

Coxiella burnetii (Q Fever) ELISA

Q fever is a potentially zoonotic, reproductive disease of ruminants and an immediately reportable disease in the state of Montana. Testing for this bacterial disease is particularly important in commercial and pet sheep herds, especially in cases where abortions have occurred. Currently, MVDL does not have the capacity to perform serological testing for this disease for either clinical or regulatory purposes.

From January 1, 2020 to January 1, 2021, MVDL referred 42 Q fever requests to other laboratories with a turnaround time of up to two weeks. By performing this test in house, turnaround time on testing results could be reduced to 48 hours, thus improving diagnostic efficiency and surveillance for this pathogen.

MVDL proposes adding this test at a cost of \$13.00 per test which is consistent with other ELISA tests currently offered.

Modifications to Miscellaneous Tests/Fees

The MVDL is seeking to eliminate the 50% surcharge on out-of-state test submissions as correctly determining whether a submission should be accessed an out-of-state charge is time consuming and may potentially require phone inquiries to veterinarians that reside in Montana and out of state for each individual submission. Additionally, the low number of out-of-state submissions annually (~10-15) will result in minimal economic impact to the lab. This change also parallels similar policy changes at other regional state laboratories, thus maintaining a more comparable market.

An increase is proposed for the after-hours carcass receiving fee, based on the costs associated with offering this service. The current fee covers only a portion of the personal services costs expended.

Several adjustments to fees for laboratory-provided kits and supplies are proposed, to better align laboratory offerings with client needs and to cover the costs associated with purchasing, storing, and distributing these materials.

Economic and Client Impact

The equine virus arteritis (EVA) virus neutralization test (\$16), mycoplasma bovis PCR test (\$36), Coxiella/Chlamydophila PCR test (\$36), pregnancy test (\$4.50), RHDV PCR (\$40), Clostridium perfringens Typing PCR (\$40), and Coxiella burnetii (Q Fever) ELISA (\$13) do not replace any existing MVDL tests, and the overall economic impact from the new fees is expected to be negligible due to low test numbers.

The giardia SNAP test will replace a currently offered \$36 test with an \$18 test, with any decrease in test fee revenue expected to be negligible due to limited test numbers. The \$7 BVDV SNAP test will replace three prior BVDV tests, the highest volume of which is the \$6 BVDV ELISA test (<2000 in FY20), resulting in less than a \$2000 cumulative annual increase. This increase is anticipated to be offset by the BVDV SNAP test also replacing the \$40 BVDV PRC test and the \$34 BVDV virus isolation test, but this effect is expected to be negligible due to low test numbers.

The adjustments and increases in miscellaneous and administrative fees will have a small economic impact, but this is expected to be negligible due to the relatively low numbers involved. Small increases in administrative fees will likely offset a small decrease associated with elimination of the out of state surcharge. However, this streamlining will result in cost savings associated with a decreased administrative burden.

There are approximately 600 veterinary submitters, at least 150 nonveterinary submitters, and 100 governmental entities only minimally affected by the proposed fee adjustments.

If persons who are directly affected by the proposed action wish to express their data, views, and arguments orally or in writing at a public hearing, they must make a written request for a hearing and submit this request along with any written comments they have to the same address as above. The written request for hearing must be received no later than 5:00 p.m., June 25,2021.

6. If the department receives requests for a public hearing on the proposed action from either 10 percent or 25, whichever is less, of the persons directly affected by the proposed action; from the appropriate administrative rule review committee of the Legislature; from a governmental subdivision or agency; or from an association having not less than 25 members who will be directly affected, a public hearing will be held at a later date. Notice of the public hearing will be published in the Montana Administrative Register. Ten percent of those entities directly affected has been determined to be 85 based upon approximately 600 veterinary submitters, at least 150 nonveterinary submitters, and 100 governmental entities affected by the proposed fee adjustments.

7. The department maintains a list of interested persons who wish to receive notices of rulemaking actions proposed by this agency. Persons who wish to have their name added to the list shall make a written request that includes the name, e-mail, and mailing address of the person to receive notices and specifies for which program the person wishes to receive notices. Notices will be sent by e-mail unless a mailing preference is noted in the request. Such written request may be mailed or delivered to the contact person in 4 above or may be made by completing a request form at any rules hearing held by the department.

8. The bill sponsor contact requirements of 2-4-302, MCA, do not apply.

9. With regard to the requirements of 2-4-111, MCA, the department has determined that the amendment of the above-referenced rule will not significantly and directly impact small businesses.

If the order directs the issuance of a new certificate that does not show amendments, the new certificate will not indicate on its face that it was amended. If the sex of an individual was listed incorrectly on the original certificate, refer to ARM 37.8.108.

(a) a correction affidavit accompanied by a completed gender designation form issued by the department certifying under penalty of law that that the individual has undergone gender transition or has an intersex condition and that the gender designation on their birth certificate should be changed accordingly, and the request for gender designation is for the purpose of ensuring the birth certificate accurately reflects their gender and is not for any fraudulent or other unlawful purpose; or

(b) a correction affidavit accompanied by presentation of a governmentissued identification displaying the correct gender designation; or

(c) a correction affidavit accompanied by a certified copy of an order from a court with appropriate jurisdiction indicating that the gender of an individual born in Montana has been changed. The order must contain sufficient information for the department to locate the original record. If the registrant's name is also to be changed, the order must indicate the full name of the registrant as it appears on the original birth certificate and the full name to which it is to be amended.

(6) A new certificate issued pursuant to (5) will not show amendments, will not indicate on its face that it was amended, and the old certificate will be placed in a sealed file. If the gender of an individual was listed incorrectly on the original certificate due to a data entry error, refer to ARM 37.8.108.

4. STATEMENT OF REASONABLE NECESSITY

ARM 37.8.102 and 37.8.311

The Department of Public Health and Human Services (department) is proposing to amend ARM 37.8.102 and 37.8.311 to meet the requirements of Senate Bill (SB) 280 passed during Montana's 67th Legislative Session. SB 280 revises vital records laws regarding the amendment of sex designations on birth certificates. Except in cases of correcting a data entry error, SB 280 provides the sex of a person designated on a birth certificate may be amended only if the department receives a certified copy of an order from a court with appropriate jurisdiction indicating that the sex of the person has been changed by surgical procedure. SB 280 requires the department to amend its administrative rules to conform with this new law and expresses an intent for the rules to be substantively the same as those in existence prior to adoption of MAR Notice No. 37-807.

Consistent with the requirements of SB 280 and the intent expressed by the Legislature, the proposed rule amendments remove language allowing for the amendment of birth certificate gender designations. The proposed rules allow for amendment of birth certificate sex designations only in cases in which there is a court order indicating that the sex of a person has been changed by surgical procedure. The proposed rules are necessary to implement the requirements of SB 280 and comply with the new law.

ARM 37.8.116

The department is proposing to amend ARM 37.8.116 to meet the requirements of House Bill (HB) 139 passed during Montana's 67th Legislative Session. HB 139 statutorily sets minimum fees the department must charge for certified and informational copies of death certificates. The bill requires the department to charge a minimum fee of \$16.00 for each certified copy of a death certificate, including any additional certified copies requested at the same time as the first certified copy. The bill also requires the department to charge a minimum fee of \$14.00 for each informational copy of a death certificate. The department has determined these minimum fees are sufficient to cover the costs currently associated with providing copies of death certificates, and therefore is proposing adoption of the minimum allowed fees.

The proposed rule amendments are necessary to implement the minimum fee requirements and to comply with the new law.

Fiscal Impact

There is no anticipated fiscal impact associated with the proposed amendments to ARM 37.8.102 and 37.8.311.

The department anticipates the following fiscal impact associated with the amendment of ARM 37.8.116.

The department processes approximately 1,056 requests for copies of death certificates per year. Some of these requests include requests for multiple copies. The department provides approximately 1,169 total copies of death certificates per year.

1,169 x \$1.00 fee increase = \$1,169.00

Under HB 139, the revenue generated from the \$1.00 increase in fees will be transferred into a special revenue account held by the Department of Labor and Industry for the general administration of the Board of Funeral Service.

Estimated number of persons affected: 1,056.

SB 276 removes language in 2-6-1101, MCA concerning microfilm project approvals and the operation of a central microfilming unit under the Secretary of State's Office. As such, all fees listed and received by the Secretary of State's Office related to microfilming services and supplies are no longer relevant or required.

4. With regard to the requirements of 2-4-302(1)(c), MCA, it has been determined that these changes will not have a fiscal impact and no persons will be affected. The Secretary of State's Office has not received payment from fees charged for microfilm services in over four years. The Secretary of State's microfilming and related practices were only available to state agencies and in the last several years were not utilized, as advances in digital storage have overtaken hard-copy records storage and rendered microfilming an obsolete practice.

5. Concerned persons may present their data, views, or arguments, either orally or in writing, at the hearing. Written data, views, or arguments may also be submitted to Angela Nunn, Secretary of State's Office, P.O. Box 202801, Helena, Montana 59620-2801, or by e-mailing angela.nunn@mt.gov, and must be received no later than 5:00 p.m., June 25, 2021.

6. Austin Markus James, Chief Legal Counsel, Secretary of State's Office, has been designated to preside over and conduct the hearing.

7. The Secretary of State maintains a list of interested persons who wish to receive notices of rulemaking actions proposed by this agency. Persons who wish to have their name added to the list shall make a written request which includes the name and mailing address of the person to receive notices and specifies that the person wishes to receive notices regarding administrative rules, corporations, elections, notaries, records, uniform commercial code, or combination thereof. TO: All Concerned Persons

1. On January 15, 2021, the Public Safety Officers Standards and Training (POST) Council published MAR Notice No. 23-13-260 pertaining to the public hearing on the proposed amendment of the above-stated rules at page 4 of the 2021 Montana Administrative Register, Issue Number 1. The POST Council held a public hearing on the proposed amendment of the above-stated rules on February 24, 2021.

2. The POST Council has amended ARM 23.13.102, 23.13.201, 23.13.215, 23.13.216, 23.13.301, 23.13.304, and 23.13.703 as proposed.

3. The POST Council has thoroughly considered the comments and testimony received. Copies of the written comments were provided to the council and will be provided to the public on request. A summary of the comments received and the council's responses are as follows:

<u>COMMENTS 1 through 3:</u> Amanda Cahill of the American Heart Association provided written and oral testimony in support of the proposed amendments to ARM 23.13.201. Joel Gaertic with the Montana State Firemen's Association and Kimberly Burdick with Chouteau County 911 provided written testimony in support of the proposed changes to ARM 23.13.201. All commenters support public safety communicators being trained in providing telephonic cardiopulmonary resuscitation (TCPR) instruction in order to provide every person experiencing a medical emergency increased chances of survival.

<u>RESPONSE TO COMMENTS 1 through 3:</u> POST agrees with these statements. With TCPR training, public safety communications officers can assist untrained callers in providing CPR and can remind CPR-trained callers how to provide highquality CPR. This will improve the services provided for the safety and wellbeing of the citizens of Montana.

<u>COMMENT 4:</u> Mark Kraft, Chief of the Sidney Police Department, provided oral testimony in support of POST's proposed changes to ARM 23.13.215. Chief Kraft testified that the proposed amendment is a common-sense change and will reduce

some of the burden of time and expense associated with agencies providing firearms instruction.

<u>RESPONSE TO COMMENT 4:</u> POST agrees with these comments and has determined that it is unreasonable for officers to be subject to the same firearms proficiency standards for their backup and primary handguns. POST further determined that the new standards will adequately protect the public while ensuring fair standards for officers.

<u>COMMENT 5:</u> Charles Kem, Stillwater County Sheriff/Coroner, provided written testimony in opposition to POST's proposed amendments to ARM 23.13.215. Sheriff Kem does not interpret the current rule to apply to backup firearms. He suggested that POST adopt only the changes to (2)(a), without providing an explicit provision for backup firearms qualifications. Sheriff Kem also suggested that POST change the proposed amendment to (2)(f) to the following language: "Secondary or backup handgun – must qualify once a year on a course of fire approved by the officer's agency head."

<u>RESPONSE TO COMMENT 5:</u> POST does not agree with Sheriff Kem's interpretation of ARM 23.13.215. Pursuant to (1)(b), every officer must complete the proficiency requirements at least once a year for every firearm that the officer customarily carries. POST does not intend for agencies to meet this standard only for primary handguns, but rather, it intends that officers meet POST's qualification standards for every firearm that they carry on duty. Leaving the course of fire up to the agencies would not ensure a minimum standard across the State of Montana. POST determines this change is reasonable and appropriate to provide an additional minimum standard for the backup handguns customarily carried by officers in Montana.

<u>COMMENTS 6 and 7:</u> Laurie Little Dog and Amanda Martin provided oral testimony in opposition to the amendment of ARM 23.13.703. Ms. Little Dog expressed concern regarding the change to (4) and stated that the agency should be required to provide a recommendation to streamline the process. She also expressed concern that the amendment of (9) provides officers more "outs" with regard to complaints. She believed that finding a complaint to be false is a "high bar" to meet, and that the public should have the ability to contest POST's findings. Ms. Martin stated her support for Ms. Little Dog's comments.

<u>RESPONSE TO COMMENTS 6 and 7:</u> POST disagrees with the comments made by Ms. Little Dog and Ms. Martin. Since POST amended (4) to allow an employing authority to make a recommendation regarding the action POST should take on an officer's certification, officers accused of misconduct have argued that POST may not take action on their certification without a recommendation from the employing authority. POST did not intend to require a recommendation by the employing authority, nor did POST intend that the absence of such a recommendation bar POST from taking action. The amendments to (9) are necessary for POST to enter accurate findings about any given allegation. POST does not intend to give an officer an "out," but instead sees these findings as necessary to accurately reflect the facts of an incident. POST sometimes receives cases with video or other conclusive evidence that directly contradicts the statements of the complainants.

The request for public recourse goes beyond the scope of this rulemaking. Any mechanism for public recourse would require another rule change and cannot be accomplished here.

<u>COMMENTS 8 through 10:</u> Josh Butterfly with Opening Doors, Marcus Bull Child, and Lyyah Lee provided oral testimony in opposition to POST's proposed amendments to ARM 23.13.102, 23.13.201, 23.13.215, 23.13.216, 23.13.301, 23.13.304, and 23.13.703. These opponents testified generally about officers' use of excessive force when dealing with members of the public and specifically about a use of force incident that resulted in a woman's arm being broken.

<u>RESPONSE TO COMMENTS 8 through 10:</u> POST finds these comments to be irrelevant to the current proposed rule changes. There are already minimum training standards for public safety officers that include training in use of force, de-escalation techniques, and related subjects.

1. On December 24, 2020, the Board of Realty Regulation (board) published MAR Notice No. 24-210-46 regarding the public hearing on the proposed amendment and repeal of the above-stated rules, at page 2296 of the 2020 Montana Administrative Register, Issue No. 24.

2. On January 21, 2021, a public hearing was held on the proposed amendment and repeal of the above-stated rules in Helena via the remote conferencing platform. Several comments were received by the January 21, 2021 deadline.

3. The board has thoroughly considered the comments received. A summary of the comments and the board responses are as follows:

<u>COMMENT 1</u>: Many commenters believed the requirements of 37-51-321(1)(a), MCA, are much more limited than the requirements set forth in ARM 24.210.641(5)(ag) and are not, as stated by the board in the notice, duplicative.

<u>RESPONSE 1</u>: The board agrees with the commenters and will retain the language of ARM 24.210.641(5)(ag), now renumbered (1)(ae).

<u>COMMENT 2</u>: Numerous commenters asserted the requirements of ARM 24.210.641(5)(ag) are necessary to adequately protect the public and should not be stricken. Further, the public should be informed of any advertising placed by a real estate licensee, so the public knows the party advertising the property for sale is an experienced and licensed real estate professional.

RESPONSE 2: See RESPONSE 1.

Montana Administrative Register

<u>COMMENT 3</u>: Several commenters believed the "theme" of ensuring that licensees disclose their status similar to ARM 24.210.641(5)(ag) is already found in statutes and board rules including the obligation to disclose when a licensee is selling his or her own personal property (see 37-51-321(1)(g), MCA). To repeal the obligation of licensees to disclose their license status unless under a franchise agreement would be inconsistent with these requirements.

RESPONSE 3: See RESPONSE 1.

<u>COMMENT 4</u>: Many commenters stated that the REALTOR® Code of Ethics requires their realtors to disclose their status as a real estate licensee in a reasonable and readily apparent manner as in ARM 24.210.641(5)(ag). While the obligations imposed by the Code of Ethics are not binding on licensees who are not REALTOR®, the commenters believed the goal of the board should be similar to that of the Code of Ethics – e.g., to establish a minimum level of professionalism to which all real estate licensees must adhere.

<u>RESPONSE 4</u>: The board appreciates all comments received during the rulemaking process.

4. The board has amended ARM 24.210.401, 24.210.643, 24.210.660, 24.210.667, and 24.210.835 exactly as proposed.

5. The board has repealed ARM 24.210.661 exactly as proposed.

6. The board has amended ARM 24.210.641 with the following changes, stricken matter interlined, new matter underlined:

<u>24.210.641 UNPROFESSIONAL CONDUCT</u> (1) through (1)(ad) remain as proposed.

(ae) failing to disclose in advertising the licensee's name and identifying that the advertisement is made by a real estate licensee or that the advertising is made by a brokerage company:

(ae) through (au) remain as proposed but are renumbered (af) through (av).(2) and (3) remain as proposed.
